On Amendments to the Rector's Decree No. 5-1/558/2021 of 27.10.2021 "On determining the status of a contact person and home quarantine during the emergency situation"

In order to ensure the introduction of the requirements of the Cabinet of Ministers Order No 720 of 9 October 2021 "On the Announcement of the State of Emergency" (hereinafter - the Emergency Cabinet Order) regarding the determination of the status of a contact person and home quarantine during the emergency situation at Rīga Stradiņš University (hereinafter - RSU), as well as certain actions for the organisation of the study process, if the status of the contact person and home quarantine are applied to persons:

it is DECREED that:

- 1. The following amendments shall be made to RSU Decree No. 5-1/558/2021 of 27.10.2021 "On determining the status of a contact person and home quarantine during the emergency situation" (hereinafter the Decree):
- 1.1. Paragraph 3 of the Decree shall be worded as follows:
- "3. As soon as a person is recognised as a contact person, he or she shall quarantine at home and shall not come to RSU or the placement site. The home quarantine may be terminated:
- 3.1. following a Covid-19 test that is taken not earlier than on the seventh day after the commencement of the home quarantine, if the test result is negative;
- 3.2. on the fourteenth day with the permission of a doctor, if a Covid-19 test is not taken.
- 1.2. The Decree shall be supplemented with the paragraph 4¹ in the following wording:
- "4.1 If the status of a contact person has been determined and home quarantine must be observed by a group of students, the studies for the particular group of students shall be organised only remotely for at least seven days, and face-to-face studies shall be resumed after the home quarantine ends. In order to ensure the notification of other RSU departments and organisation of remote studies, the Study Department and Deans may use the assistance of the student group leaders in circulation of the information.
- 2. The staff of the Rector's Office shall:
- 2.1. inform the following people of this Decree: T.Koķe, Vice-Rector for Studies; G.Bahs, Vice-Rector for Health Studies; A.Kiopa, Vice-Rector for Science; P.Feldmane, President of the Student Union's Board and Deans of RSU Faculties;
- 2.2. inform all RSU employees of this Decree;

- 3. Deans of RSU Faculties shall inform Faculty students of the adjustments to the conditions of the Decree.
- 4. The staff of the Quality Assurance and Internal Audit Department shall ensure the availability of this Decree (consolidated version) in RSU Document Centre.
- 5. The amendments to the Decree shall come into force on 17 November 2021.
