  - a) in the event of conclusion of the licence agreement, an initial fixed payment of a total of EUR 3000 (three thousand euro) excluding value-added tax is foreseen,
  - b) the initial interest payment amount of the Auction is 6% (six percent), therefore the offered interest payment cannot be lower than 6.5% (six and a half percent) of the Licensee's annual net turnover from sales of products,
  - c) the interest payment offered by the Auction Participant is the value, with which the Auction Participant competes with other Auction Participants by setting the highest proposed price for the object.
